Notice is hereby provided to all Retired members of the Ventura County Employees' Retirement Association (VCERA) that elections will be held for a Retired Member representative and Alternate Retired Member representative to serve a term on the Board of Retirement commencing January 1, 2027 to December 31, 2029.

Oversight of VCERA is vested in the Board of Retirement, which consists of the County Treasurer, four appointees of the Board of Supervisors, two members elected by General members, one member elected by Safety members, and one member elected by Retired members. The Board also includes one alternate Safety member, one alternate Retired member, and one alternate appointee of the Board of Supervisors.

Nomination Documents

Retired members interested in being a candidate for the position may obtain nomination documents from VCERA by appointment only; request by phone at (805) 339-4261 or by email at info@vcera.gov. Nomination documents will be available on July 13, 2026 and must be returned to the VCERA office by 5:00 p.m. on August 5, 2026. Documents received after the deadline will not be accepted.

For a Retired member to qualify as a candidate, his or her nomination petition must be signed by not less than 20 nor more than 30 Retired members. At the time the nomination petition is filed, a candidate statement of qualifications consisting of 200 words or less may be filed by the candidate. The Candidate Statements of qualification will be distributed along with all other ballot materials.

Ballot Distribution

The official ballot for the election, voting instructions, and candidate statements of qualifications will be sent by U.S. mail to eligible Retired members on August 31, 2026. Ballots will be mailed to voters at their address on file with VCERA.

Voters have until 5:00 p.m. on September 29, 2026 to complete and return their ballots (in person or by U.S. mail) to the Elections Division, located at 800 S. Victoria Avenue, Ventura, CA 93009-1200. (Mail must be received by the deadline, regardless of postmark.)

Official Canvass

On September 30, 2026, beginning at 10:00 a.m., voted ballots will be counted in the Elections Office. The Certificate of Election Results will be received by VCERA by 5:00 p.m.

July 6th	Election Announcements to be mailed from VCERA to Retired members.
July 13th	VCERA to generate a list of all Retired members who are eligible to run and vote in the election.
July 13th	Nomination Packets will be available from VCERA. An appointment is required to obtain a packet, and can be made by contacting VCERA by phone at (805) 339-4261 or by email at info@vcera.gov .
August 5th	Nomination Packets must be returned to VCERA by 5:00 p.m.
August 6th	VCERA will conduct a random alphabet drawing at 9:00 a.m. to determine order of placement of names on ballot, then email results to Elections, along with voter instructions and mailing lists.
August 31st	Official ballot packets, with Instructions for Voting and Candidate Statements, to be distributed by U.S. mail to all eligible Retired members.
September 29th	Election Day. Voted ballots must be returned to Elections Office by 5:00 p.m., including mailed ballots.
September 30th	The Elections Office will begin tallying votes by 10:00 a.m., and will subsequently certify results and notify VCERA by 5:00 p.m.
October 2nd	VCERA to submit certified election results to the Board of Supervisors to agendize for receive and file. The Elections Office will retain election materials for six months, then return them to VCERA.
January 25th	Oath of Office to be administered at the January 25, 2027 Board of Retirement meeting.
